With a fixed supply of 5 trillion coins, algorithmic scarcity, and real-world utility, GGC fosters a self-sustaining ecosystem for 50 million+ Indian users. Built on scalable SQL infrastructure, GGC prioritizes speed, cost efficiency, and accessibility while enabling peer-to-peer trading and utility-based value growth.

**Vision:** Democratize education by transforming knowledge acquisition into tangible value.

**Mission:** Empower users—students, professionals, and underserved communities—to earn digital assets through skill development.

**Platform:** GEN Gama, an educational hub offering bite-sized courses (2,000 words) and competitive quizzes.

**Token Role:** GGC bridges learning, utility, and digital commerce, creating India's first education-centric token economy.

### 3. Tokenomics & Minting Mechanism

#### 3.1 Coin Minting

- **Source:** Users mint GGC by completing courses and exams
- **Credit System:**
  - Correct answer on 1st attempt: **5 credits**
  - Correct answer on 2nd attempt: **3 credits**
  - Correct answer on 3rd attempt: **1 credit**

#### 3.2 Minting Formula

- **Base Rate (May 29, 2025):** 1.5 GGC per credit
- **Daily Decay:** Minting rate reduces by **0.3% daily** to reward early adopters
- **Supply Cap:** Hard-capped at **5 trillion GGC**

#### 3.3 Value Growth

- **Utility Appreciation:** GGC's value for platform utilities increases by **0.3% daily**
  - **Market Valuation:**
    - Initial rate: **₹0.01 (1 paisa)** per GGC (May 29, 2025)
    - *External marketplace rates are demand-driven and unregulated*
